

We, a multi-national group focused on fighting current and future pandemics, leveraging a data-driven systems approach, would greatly value your participation in a virtual working meeting scheduled for <u>18 February 2021</u> at 10:30-12:00 EST US/16:30-18:00 CET. We are seeking participation in a rapid effort to standardize key data documenting vaccine administration.

There is great urgency, requiring immediate action. Nations, jurisdictions within nations, and tech companies have initiated work on vaccine documentation applications and associated standards. Unless quickly replaced with a single consensus standard, these disparate efforts will inevitably lead to a global Tower of Babel that will not only aggravate trans-border spread of disease, but also greatly complicate travel, education, and commerce.

The virtual working meeting will be hosted by a group of experts from Spain, Italy, and the United States. This collaboration was initially convened in April 2020 and is hosted by the Learning Health Community, a not-for-profit organization dedicated to improving the health of individuals and populations. Addressing the Covid-19 pandemic and future public health challenges through global collaboration and a data-driven systems approach (wiley.com) describes an approach to optimizing the value of the vast amount of Covid-19 data, which continues to be amassed, to inform decisions that are crucial to managing the pandemic.

The <u>18 February 2021</u> meeting will be narrowly scoped to initiate a process to converge quickly upon a parsimonious, precisely described vaccine documentation standard to be rapidly published, sending a clarion message that a healthier world requires such a standard. We propose to simultaneously advance this standard, published as provisional, through an appropriately broad and robust consensus-based process enabling it to be quickly and universally adopted.
